- **Produce a Tangible Result:** We will walk out of this meeting with a "Community Accountability Blueprint" that we can officially submit to the city and the School of Mines.

This isn't just another meeting to air grievances. We will be discussing specific, creative, and practical solutions. For example:

- **For the dangerous Tangent intersection:** What if we installed a "smart" cyclist detection system—using the same technology the city already uses for the elk crossing—to give drivers a real-time warning?
- **For the future Elm Street crossing:** What if we built in accountability from the start with a permanent QR-code reporting tool, empowering residents to instantly report near-misses and contribute to a public safety dashboard?

These are the kinds of forward-thinking ideas we will build upon together. This is what my commitment to **"Consult, Co-Design, Deliver"** looks like in action. It's how I believe our city should be run—with professionalism, preparation, and a deep respect for the wisdom of our community.
